## **CHRISTMAS LIGHTS**

### **To Illuminate the Fountain as per last year:**

White lights 2019 = £270

White lights 2020= £270

### **Community Hall Car park:**

Light up the Tree that was lit last year (the lights were left in the tree so will only require a safety check) 2020 = £50

Car park entrance tree and bushes either side 2019 = £300

As above 2020 = £300

### **Proposed new ideas for 2020, for discussion:**

The Fountain:

2 artificial 5' trees to be placed in the existing brackets on the side of the toilet building, tree plus white lights=£ 50.00 each.

Exterior Icicles hung along roof soffits / apex of the toilet block, (white)=£100

Exterior icicles hung up along the roof apex, both sides above the town tree, (white to match tree) =. £ 175.00.

Large lamppost feature to go next to town tree = £ 200 .00

Fore Street lamppost features =£ 200.00. (There is a total of 6 lampposts)
